Zoological Park Education Center and agrees to indemnify, defend, and hold harmless Wildlife Rehabilitators of North Carolina, the Education Center, and its owners, agents, and employees against all claims or expenses for such losses, including reasonable attorney's fees, arising out of the use of the center premises, excluding any liability caused by the negligence of WRNC or the Center or its owners, agents, and employees.

The exhibitor understands that neither WRNC nor the Education Center maintains insurance covering the exhibitor's property or lost revenue, and it is the sole responsibility of the exhibitor to obtain such insurance.

2. Each exhibitor will be provided with a six (6') foot table. Displays must be contained to the table area assigned.

3. The exhibit area will be available for set up of exhibits on Saturday, January 27, 2007 at 7:30 am.

4. Exhibitors must conform to the fire regulations of the City of Asheboro and the regulations of the N.C. Zoological Park Education Center.
