2. The exhibitor understands that neither WRNC nor the North Carolina College of Veterinary Medicine maintains insurance covering the exhibitor's property or lost revenue and it is the sole responsibility of the exhibitor to obtain such insurance.
3. Each exhibitor will be provided with a single six (6') foot table.
4. Displays must be contained to the table area assigned. You are encouraged to bring a sign to hang on the front of your table to identify your group.
5. The exhibit area will be available for set up of exhibits on Saturday, January 28th, 2012 at 8:00 am. **Your exhibit must be removed from the exhibit area by 2:30 pm on Sunday, January 29th, 2012.**
6. Exhibitors must conform to the fire regulations of the City of Raleigh and the regulations of the North Carolina College of Veterinary Medicine.
7. Moving exhibit items into and out of the center is the sole responsibility of the exhibitor. There will be only a few carts available for sharing on a first come, first serve basis. You are encouraged to bring your own cart.
